**The Traffic Signs (Temporary Obstructions) (Amendment)
Regulations 2010**

The Secretary of State, in exercise of powers conferred by section 64(1) and (2) of the Road Traffic Regulation Act 1984(a), makes these regulations.

In relation to these regulations, the Secretary of State has, in accordance with section 134(2) of that Act, consulted with such representative organisations as he thought fit.

Citation and commencement

1. These regulations—
 - (a) may be cited as the Traffic Signs (Temporary Obstructions) (Amendment) Regulations 2010; and
 - (b) shall come into force on [...].

Preliminary

2. The Traffic Signs (Temporary Obstructions) Regulations 1997(b) are amended as follows.

Amendment of regulation 8

3. In regulation 8 (keep right sign), in paragraph (b), for “900 millimetres” substitute “600 millimetres”.

EXPLANATORY NOTE

(This note is not part of the instrument)

This instrument amends the Traffic Signs (Temporary Obstructions) Regulations 1997.

Regulation 15(1) of those regulations authorises the placing of a keep right sign for the purpose of warning vehicular traffic of the obstruction created by an emergency or breakdown vehicle which is temporarily obstructing a road. Regulation 8 of those regulations prescribes the keep right sign. Regulation 3 of these regulations amends that regulation 8 so as to reduce from 900 millimetres to 600 millimetres the minimum diameter of the sign.

This instrument was notified in draft to the European Commission in accordance with directive 98/34/EC as amended by directive 98/48/EC.
