Annual Conference 2018 (and Brexit)

It is now more than 24 months since the referendum and there are less than four months to go before exit day, yet the uncertainty continues. This uncertainty overshadowed the Conference, as it did in 2016 and 2017.

At the Annual Conference, there was a discussion of the likely consequences of several possible outcomes of the Brexit negotiations. The discussion then quickly moved on to the UK's metric changeover, past, present and future. The media coverage of this year's heat wave was reviewed, there was a presentation on the Report of 1819 which had led directly to the current mess of measurement units. There was then a discussion on progress, or lack thereof, on UK road traffic signs. A member outlined Canada's experience of metrication, "living next to a bossy neighbour", before the Conference moved on to discussing an awards scheme and other organisational matters.



The Commission's Report of 1819

There was a presentation at the Annual Conference about the 1816 report of the Select Committee on the Original Standards of Weights and Measures and the reports of 1819, 1821 and 1822 by the Commissioners appointed to consider weights and measures. These reports led to the Weights and Measures Act of 1824, to the so-called imperial system of measures, and to the UK's current measurement muddle. Had the Commissioners seen the potential of the metric system, history could have taken a very different turn.

The Committee will be considering how to mark this anniversary. Readers' suggestions are welcomed.

UK's measurement muddle gets a mention at the European Parliament

The subject of measurement units has been conspicuously absent from the debate in recent years about the UK's future relations with the EU. But there was a brief mention on 23 October when Guy Verhofstadt, the European Parliament's Brexit co-ordinator, joked: "I know Britain has always had difficulties with the metric system."

Of the four EU countries that were using imperial measurements at the time of their accession, three have converted their road traffic signs, namely Cyprus, Malta and the Republic of Ireland. Only the UK has not. The UKMA Metrication Board had suggested the job should be done in 1973. But after repeated postponements, plans were abandoned with an announcement from the UK Government in 2006 that, "It had saved the pint and the mile". Our continental neighbours must have looked on with a mixture of amazement, that a trading rival should handicap itself in this manner, and of annoyance, that an obligation freely entered into should be casually abandoned. But they were too polite to say anything.

That is until a month ago.

Two kinds of country

An article on Metric Views, posted on 16 October, discussed the use of metric measures in the US Apollo program, culminating in the moon landings between 1969 and 1972:

This meme relates to the article:



The article was prompted by the release of "First Man", a film about Neil Armstrong who, nearly 50 years ago, was the first man to walk on the Moon. One of mankind's greatest achievements.

Amongst the conspiracy theories and misinformation surrounding the Apollo missions, there is an anti-metric meme, sometimes used on social media, that asserts that NASA did not use the metric system in the Moon landings. The meme reads something like this: "There are two kinds of country – Those that use the metric system, and those that have landed on the Moon." The article refutes that view with information about the extensive use of metric measures in the Apollo program.

"Shouldn't we be referring to the UK's 'measurement upgrade' rather than 'metrication' or the 'metric changeover'?"

AD of Rochdale writes,

"I've noticed a creeping trend where coffee shops (both chains and independents) display cup sizes in fluid ounces only. Is there anything UKMA as an organisation can do to campaign against this? "

MV of Fleet, Hants comments,

"On reading the article on heating for the elderly, one thought crossed my mind – any thermostat that is calibrated in Fahrenheit probably needs replacing as it is likely to be over 40 years old! Advice concerning heating for the elderly should therefore give degrees Celsius only with a note that devices that display Fahrenheit only are probably unreliable due to age."

KM, a follower on our Facebook page, puts us on the spot,

"One question I have is: why don't you/we adopt a more robust campaigning tone? Many of the examples in the newsletter seem to describe things in a way which views them as somewhat cute British eccentricities, rather than ridiculous anomalies in the modern, globalised world.

While I understand that UKMA doesn't take a position on the UK's membership/relationship with the EU per se, I do think we need to take the clear view that the preservation of the British tradition that is the imperial system is silly and retrograde, and that this is indeed an aspect of British society and culture where we feel homogenisation with the rest of the world is on balance absolutely a good thing - and be clear and unashamed about that and the reasons why.

What are your thoughts?"

UKMA Style Guide

In 2012, UKMA produced a measurement units style guide. This was based on British and internationally agreed standards, and represents best practice. It gives guidance on how to use and write metric units, mistakes to avoid, what to do about conversions, and where to find further information. It also gives a brief explanation of the principles of the metric system.
